### Important information concerning your membership application subscription

The membership year runs from the 1<sup>st</sup> of April to the 31<sup>st</sup> of March each year.

Those joining after the 1<sup>st</sup> of April will be charged the joining fee plus the membership fee on a pro rata basis of the number of quarters remaining in the membership year.

Your membership expires on 1<sup>st</sup> April annually and a re-joining fee applies in this case. All breeds need to pay annual prefix maintenance.

#### For example:

A single adult joining at any time during the 2<sup>nd</sup> quarter (i.e. 1<sup>st</sup> July to 30<sup>th</sup> September), will pay the joining fee, \$16.00 plus \$24.00 (\$8.00 x 3 quarters) = \$40.00.

A family joining at any time during the 3<sup>rd</sup> quarter (i.e. 1<sup>st</sup> October to 31<sup>st</sup> December), will pay the joining fee: \$16.00, plus \$32.00 (\$16.00 x 2 quarters) = \$48.00.

**Please Note:** A quarter runs from the 1<sup>st</sup> of the month until the end of the month 3 months later and, for the CAT financial year, are as follows:

1 <sup>st</sup> quarter	1 <sup>st</sup> April – 30 <sup>th</sup> June
2 <sup>nd</sup> quarter	1 <sup>st</sup> July – 30 <sup>th</sup> September
3 <sup>rd</sup> quarter	1 <sup>st</sup> October – 31 <sup>st</sup> December
4 <sup>th</sup> quarter	1 <sup>st</sup> January – 31 <sup>st</sup> March
